Hi Joanna,

I took a screenshot of the pickup orders with Waste Management (attached). The couch was originally scheduled to be picked up on March 14th and it has a timestamp when it was "serviced" on that day, but it was not. I thought it was because of the snowbanks that were still in the alley so I waited. I have EOW removal so I thought they would pick it up two weeks later, but they did not. That's when I checked my account and saw that it was marked completed. That started my many attempts to try to get ahold of a real person to reschedule (the automated online bulk pickup scheduling process was not working...it may still not be working). When I finally got through to someone at WM they told me the earliest they could reschedule a pickup was on my regularly scheduled trash pickup day @two weeks later. The city collected the couch the week before that second pickup date of May 9th. It was all very frustrating because I initially scheduled my new couch delivery around the day I could dispose of the old one expressly so that it would only be in the alley for a day.

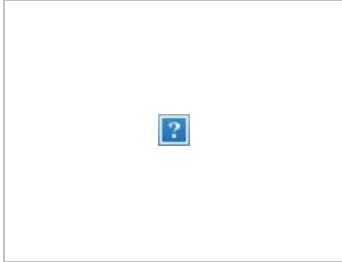
