Agenda: The following requests have been submitted to change [skyway hours of operation](#) in specific areas. Each of the following will be voted on by the committee, and the committee recommendations will be sent to the City Council for a vote. If time allows, there will be additional discussions with managers from the Saint Paul Police Department, Metro Transit Police, and Saint Paul Department of Safety and Inspections (DSI).
