I received the photos that you shared. Thank you for double checking your sent messages to find them.

From what you shared, I am counting 54 bags during April-June.

33 of the bags that you sent pictures of are dated July & August; these should be applied to the Q4 bill. Given this information, the total bill sent to the city for assessment payment in Q3 should have been:

2 - 96gal carts (\$116.40 each) + late fees (15%) = \$239.78

54 - Extra bags (\$3.00 each) + late fees (15%) = \$186.30

Total= \$426.08

This would mean a total reduction in payment of \$163.51

Let me know if you see any errors in my calculations and please reply by noon tomorrow.
