To Whom It May Concern:

I am writing to request an appeal of the Vehicle Abatement Order issued against my property on April 30th, 2024 by inspector Anthony Munos Badge Number 331. My husband and I purchased our home at 408 Hazelwood Street, Saint Paul, Minnesota 55106 on April 30th, 2019. For the past five years we have resided here and worked to make our neighborhood a better place. We are raising three children in this house, one of whom has special needs due to a stroke at birth. We have two cars parked in what we consider to be our driveway. When we bought the house, there was a very small concrete pad followed by a gravel parking space. The Vehicle Abatement Order says that per Chapter 45 we are parking our cars on an unimproved surface. I would like to appeal this and delay having the cars impounded while I seek more information.

First of all, the abatement order was filed against both my Dodge and Buick. I need clarification on why the order is issued against both parking spots. As you can see in the picture below, the Dodge is parked on a gravel surface as is allowed in Chapter 45 Section 34.07. I am in the process of trying to sell the Buick.

Second of all, can I get site plan approval to use the space the Buick is in as a parking space? I have had issues in the past parking my cars on the street. People frequently try to break in and I have had the hood dented with people trying to steal the battery out of my car. I have been using these parking spots for the past five years and not had trouble with people trying to break in when they are on my property. Parking on the street can also be difficult with winter plow routes. We are a family of five living on less than \$60,000 a year. Paving the driveway and improving the surface would be a financial hardship. Can we please be allowed to continue parking our cars where they are?
