If you want to make a one-time payment by credit card, please call our office with your payment information. Alternatively, we can do recurring automatic payments with either a credit card stored or with direct withdrawals from a checking or savings account. If you choose to setup automatic payments, your account will be charged on the 15th of each billing cycle.

“Thank You” for choosing Highland Sanitation & Recycling Inc. We are a third generation, family-owned business. Highland Sanitation has been in business since 1950 and was established by Susan’s parents, Emil and Alice Oehrlein. The business operations are now run by Susan’s son Bobby as the company transitions to the next generation of our family serving your family! We strive to provide you with timely, courteous service as well as a live person to talk to if you should call rather than an automated attendant or out of state call center.

Please be advised that our trucks are at their first stop by 6:00am. Even though they are usually at your stop around the same time every week, there are times when we are earlier or later, therefor we request that you have your trash and/or recycling and/or yard waste out by 6:00am or the night before. If you set your carts out after we’ve been by, we charge a fee to come back and get your trash.

The volume-based rate that you have signed up for is for household trash only. Dirt, remodeling, concrete, tar, shingles, wood, furniture, brush, electronics, etc. in the cart are not considered household trash and will be charged according to what you have out. If the lid on your cart is not shut, or if you have extra bags alongside of the cart, there will be overage fees charged per bag at \$3.00 per bag. Please call us at least two days ahead of your pickup day to let us know if you have extra non-bag items to be hauled, otherwise the extra items will not be hauled.

Yard waste will be hauled from April 18 thru November 30, 2022, depending on the weather and closure of the yard waste site. Yard waste can be called in at a cost of \$3.00 per 30-gallon bag or we do offer carted, seasonal yard waste service with a cart, please call for details!

We have 10/15/20/25/30 cubic yard Roll-Off containers available for remodeling jobs and household cleanups. We need at least 3 days’ notice to schedule these to go out.

Christmas tree removal is free for one live Christmas tree under 6 feet tall and without ornaments & etc. between January 1 and January 15th each year on our dedicated Christmas tree route that diverts the trees away from the incinerator and to a compost site. Christmas trees over 6 feet tall will be charged at \$10.00+tax. Please call our office to schedule a Christmas tree pickup at least two days in advance or your tree will not be hauled.

Our office hours are Monday through Friday 8:00am to 4:30pm
