Hi Bruce

I show you have 159 Granite St on a service hold, and you should not be charged for service after July 1, 2024. As for your pending Quarter 1 assessment, you will need to contest the charges at a Legislative hearing to see if we can have it reduced. The Quarter 1 legislative hearing is on Thursday, July 25 between 9 and 11 am. Would you like me to add you on the schedule? I can give you a more approximate time once I schedule the hearing.

Your Quarter 2 assessment is still being processed and finalized with the city. Depending on the outcome of the legislative hearing on July 25, we might be able to request the same outcome without having to go to another legislative hearing, but that is entirely up to Waste Management. Worst case scenario, we would go to a legislative hearing in October for the Quarter 2 assessment.

Let me know if you want to appeal the charges on July 25.

Hi Bruce

I show you have 159 Granite St on a service hold, and you should not be charged for service after July 1, 2024.

As for your pending Quarter 1 assessment, you will need to contest the charges at the Legislative hearing on July 25 between 9am and 10am to see if we can have it reduced. I have you down for a phone attendance. My role in this is to present the facts for both you and the hauler, and the hearing officer makes the decision. Once the hearing officer has come to a conclusion, it is sent to Public Council where it is approved. You do not need to attend that hearing unless you are unhappy with the results on Thursday.

I forgot to mention that depending on the outcome of the hearing on July 25, we might not need a legislative hearing in October. But both quarters do have to be processed separately. I will hold off on moving forward with Quarter 2 until after your hearing on Thursday.
