Mr. Eggen,

At the Council Public Hearing Wednesday (7/16), she will ask the Council to continue the matter to Council Public Hearing Wednesday, August 13, 2025 at 3:30 pm. If the project is completed by that time and has recivied its Code Compliance certificate, she will recommend a reduction of the assessment by half (\$5,077 to \$2,539), otherwise the recommendation will be to approve in full.

No need to attend this Wednesday, I will send information on how to testify on 8/13 in my follow up letter should you wish too.

Can you relay this to Mr. Mortimer? I will send a formal follow up letter out, but I doubt he will receive it by Wednesday.
