It is my understanding with the information at hand, that 805 Minnehaha Avenue West was **not** "okayed for a gravel parking pad per the hearing back in December."

Mr. Turner, to reiterate, the attached plan as submitted in PAULIE under DSIPLZNPP-000422-2026 was denied per section **Sec. 63.316. – Paving**.

It is advisable to resubmit utilizing one of the approved materials:

- standard or pervious asphalt or concrete
- brick
- concrete or stone pavers

At the time of resubmittal, please provide the dimensions of the existing driveway leading up to the garage with curb-cuts off Avon Street North.

Please note that PAULIE will be unavailable to the public and City staff beginning Wednesday, April 1st, at 6:00 pm to Monday, April 6th, 8:00 am due to legacy data migration.

Rashad Turner,

Did you submit a site plan to Grace Wagner for approval as parking for the area beside the garage? That is the area that needed approval from Zoning if you want to continue parking there, not in the back.

Below is what was said at the hearing:

Moermond: there were orders for vehicles parked in the back yard. He doesn't have any space on the property for parking except for the garage and the apron. When he had a vehicle and trailer, boat, car in back yard and also in the area between garage and fence opposite, none of which is approved parking. We gave an extension for compliance to December 31 to at least be between garage and side of property, not in back yard. He did move those things, and the expectation is they will be completely gone unless he has it approved as parking. He was given until April 1 to be approved as parking beside the garage to be continued use of that space for parking.
