To Whom it May Concern:

My name is Beth Fegley and I work for Wilmington Trust on a team that specializes in the closing of trust accounts for the Bank. I am coordinating the closing administration for the Trust referenced above.

Due to the death of Nancy Sittard, the Trust will be closing. Your organization was named as a remainder beneficiary of 10% of the Trust, with the gift intended to be used to purchase, train and care for police dogs.

It is our intention to settle the Trust informally, meaning we would like to do so without Court adjudication. Please be aware you will have the same opportunity to review the Bank's work as Trustee and raise any objections as you would with a formal settlement. The informal settlement of the Trust is typically quicker and can be done with less expense. Please note we can switch to a formal settlement and get an adjudication if you choose or if an issue arises during the closing that would dictate that we make the switch.

I have enclosed the following documents related to the closing of the Trust:

1. A copy of the Trust agreement.
2. An accounting of the Trust.
3. Our standard *Receipt, Release and Indemnification Agreement*. If the release is in order, **please sign and date in the presence of a notary public, and return the signature page to me. Please also include a form certificate of authority or resolution recognizing the person signing.**
4. A Holdings List, showing the assets currently in the Trust
5. A Schedule of Distribution, showing the approximate amount to be distributed.
6. A Letter of Direction indicating where you would like the funds sent. **Please complete and return to me.**
7. An IRS form W-9. **Please complete and return to me.**

You have the right to request any historical information related to the Bank's administration of the Trust, including a full accounting of the trust. We highly recommend you review the information and ask any questions related to the administration of the Trust prior to signing the Release. You should also seek out your own legal counsel if you have any questions regarding any legal interpretation of the Release Agreement and/or legal implications of signing the Release Agreement.
