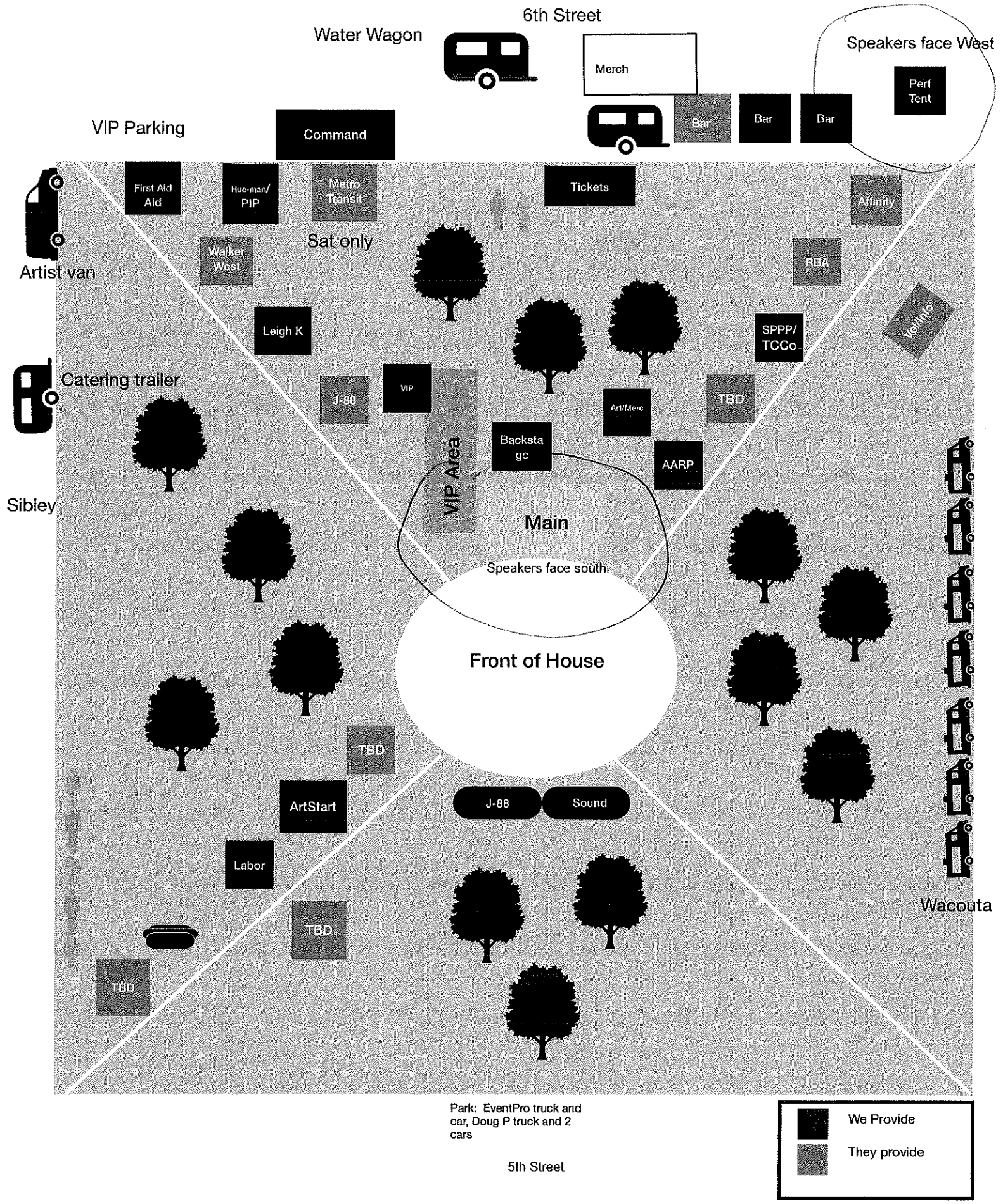
Sound Level Variance Application
