



Local 2508: St. Paul Clerical

Members of the Saint Paul City Council,

AFSCME Local 2508 St Paul Clerical **strongly urges you to reject making the Deputy City Clerk an appointed position.** This ordinance is harmful and disrespectful to union employees. There is no clear need for this role to be non-represented. We instead urge you to recreate the role of Deputy City Clerk in a certified capacity entitled to representation either within AFSCME or one of our multiple sibling unions.

The reasons for our opposition are:

- **This position would do work that is currently done by a union employee.** These duties include generating, publishing, and noticing your meeting agendas. The essential duties of this role continue to fall squarely within clerical, non-political work.
- **This will result in the loss of a union job.** City Council staff have been told your office would have one less union job if this ordinance passes and a Deputy City Clerk is hired.
- **The Deputy City Clerk role should remain as a civil service position to allow for greater continuity of service in the clerk's office.** Elected and appointed officials can change after an election, and there needs to be someone to carry on the work of the office. The clerk's office was moved from the Mayor's Office into the City Council because it should not be political. If the charter didn't designate the clerk as an appointed role, we would fight for that position to have a contract as well.

When looking at the history of those who held the Deputy City Clerk/Assistant City Clerk role in the past, Shari Moore, Fran Swanson, and Loraine Anderson were all represented by the Saint Paul Supervisor's Organization (SPSO) when they held this role. There has been only one substantive reason given as to why the council should de-unionize this position, and that rationale does not hold up under scrutiny.

The statement that this position needs to be appointed to allow for signing authority is simply untrue. Many official, legally-binding documents are signed by union-represented staff on behalf of the City every day. Our city's history of previous Deputy City Clerks with union-representation further disproves this stated need.

It is understood that a Deputy City Clerk is needed. Since early November, one of our AFSCME 2508 members in the role of City Council Executive Assistant has carried out the

majority of these responsibilities while working out-of-title. This underscores the need for the job, and also the fact that it aligns with the work of union-represented employees.

It is not understood why this position should go without a contract and collective bargaining. Union representation is not a barrier to professional compensation or operational efficiency. Employees should not have to choose between promotions and labor rights.

There are multiple paths that would allow the Deputy City Clerk to remain in a union. We look forward to discussing those options with you. Please oppose this ordinance and affirm that the Deputy City Clerk position deserves union representation.

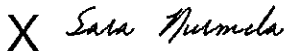
