Brendon Smith is the adult child of record owner, Thomas Charles Smith, who passed away in 2022. I am enclosing an Amended Order from Ramsey County District Court File No. 62-PR-24-469, in which Brendon was determined to be the 100% owner of all assets owned by his father, which includes 74 Congress Street. By that same order, Brendon was prohibited from deeding the property to himself due to Medical Assistance liens on the subject property. I am enclosing the correspondence with Ramsey County, which outlines Brendon's request to reduce or remove the lien. The subject property is also in foreclosure and has been listed for sale. Appellant requests that the City take no further action on this property for 180 days so that Brendon may live in the home until the redemption period ends on December 10, 2026, and / or seek to sell it during the redemption period. Dear Mr. Rominski:

Thank you for speaking with me last month about this matter. You will recall that my firm represents Brendon Michael Smith in connection with his inheritance of the home at 74 Congress Street in Saint Paul (the "Property"). Mr. Smith became the owner of the Property pursuant informal probate proceedings in 2024 after Mr. Smith's father, Thomas Charles Smith, passed away in 2022.

Mr. Smith is a 49 year-old disabled adult who has lived in the Property since 1985. The Social Security Administration determined Mr. Smith to be mentally and physically disabled in 2007. Mr. Smith has very limited records, but he has provided me with a copy of his Social Security Administration award letter that I have enclosed. Mr. Smith lives below the federal poverty level and receives Medicaid benefits and Minnesota SNAP benefits and I am enclosing documentation of his receipt of those benefits. I would also note that the SNAP benefits statement from this month shows monthly gross income of \$860.00.

Mr. Smith provided care and support to his parents, Thomas and Linda Smith (d. 2020), during their lives and during their final illnesses.

The property is subject to a Medical Assistance lien arising from Linda Smith's end-of-life care in the original amount of \$330,954.44. The Property is in foreclosure because the mortgage granted by Thomas and Linda Smith is in arrears in the amount of \$20,655.34. The foreclosure sale is scheduled for June 9, 2026. The total amount owed on the mortgage is approximately \$190,000. Mr. Smith does not have the resources to reinstate the mortgage nor redeem the Property from foreclosure. I am enclosing the notice of sheriff's sale that Mr. Smith received earlier this month.

I believe that enforcement of the Medical Assistance lien would cause Mr. Smith to undergo an undue hardship as it will prevent him from realizing the equity in the Property that Mr. Smith needs to obtain housing and medical treatment. My firm is not charging Mr. Smith anything nor claiming any lien or interest in the Property.

My firm is able to assist Mr. Smith with selling the home and completing the necessary probate work to sell the Property at arm's length if Ramsey County Human Services will release the Property and Mr. Smith from any claim to the net proceeds should he find a buyer before the end of the redemption period.

Please accept this letter as Mr. Smith's request that Ramsey County Human Services release Mr. Smith and Property from the Medical Assistance lien to avoid an undue hardship. I am available to speak with you and provide any further documentation to facilitate your review of this request.

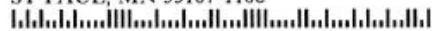
